## Partnership with B-CC High School Since 1995

For over 20 years, the B-CC HS Educational Foundation has partnered with the school to support programs that make a real difference in the lives of the students and teachers. This year we invested in dozens of programs that would not have been possible without the generous support of our donors—parents, alumni, and local businesses.

The Foundation's outlay in FY2016 totaled \$164,000, with 90% going to support grants and programming at the school. The remaining 10% were on fundraising and administrative expenses.

The FY2016 grants funded a continuum of academic support programs for students and a variety of professional development and investments in teachers. Here are a few highlights:

- 75 at-risk rising 9th and 10th graders participated in the Summer Academy program to build the literacy, math and leadership skills they need to be successful in the coming school year.
- 100 rising 12th graders had a completed essay in hand when they finished their week-long College Essay Writing Workshop taught by B-CC English teachers.
- B-CC students in all grades made over 1,900 visits to TAP for after-school academic help.
- Over 200 B-CC students participated in

CollegeTracks, a college access and success program with a nearly 100% success rate.

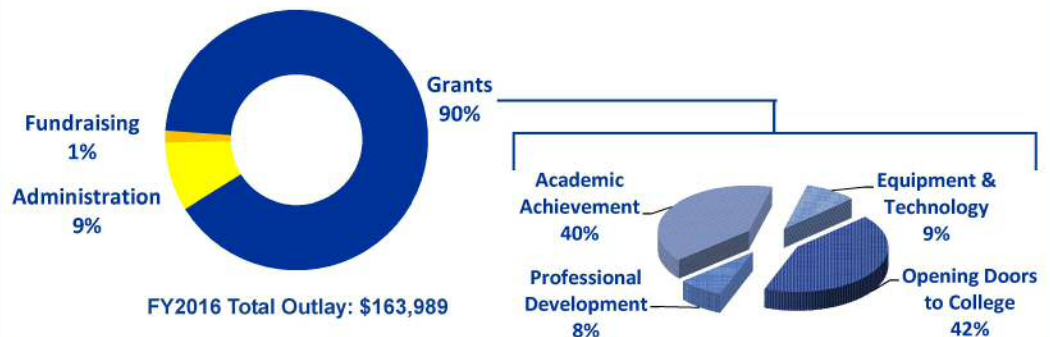
Following is a summary of all the Foundation's grants made to B-CC in the 2015-16 school year:

- Summer programs to help students better prepared for the school year ahead: *Summer Academy, College Essay Workshop, Girls Leadership Workshop, and Journalism & Media Literacy Workshop*
- School-year programs to provide academic support and enrichment for all students: *TAP, Academic Peer Partners, B-CC Annual Writing Contest, Theater Master Classes, IB Diploma test fees, TOEFL exam fees, and Lazarus Fellowship Program*
- Year-long programs to expand post-secondary options for students who lack financial resources or experienced adults to guide them outside school: *CollegeTracks*
- Technology and Equipment to improve classroom resources: *a Chromebook cart, a Media Center multimedia projector, a full-size conservatory-style key system oboe for the orchestras, a SPARKvue sensor bundle for Physics, and software for the Tattler*
- Professional development for teachers to gain new knowledge and innovative skills to enhance their teaching and support for students

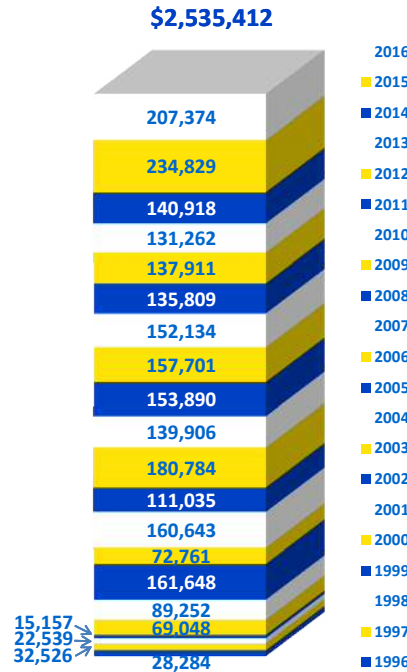
## Foundation Revenues

Working closely with the principal, the school staff, and the PTSA, the Foundation identifies unmet needs at B-CC and raises the necessary funds for programs that give all students at B-CC the skills they need to flourish and succeed. In FY2016, thanks to the generosity of our do-

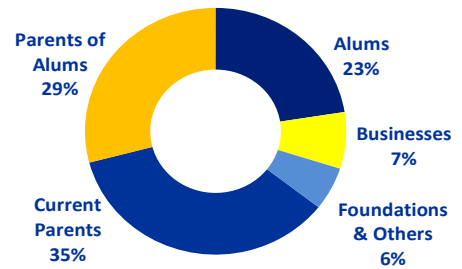
nors, the Foundation raised \$207,374, bringing the total amount of funds raised since 1995 to over \$2.5 million.

Parents of B-CC alums contributed \$64,969 and parents of current B-CC and Westland students contributed \$78,877 to the Foundation this past year. Together they accounted for 64% of total donations received by the Foundation in FY2016.

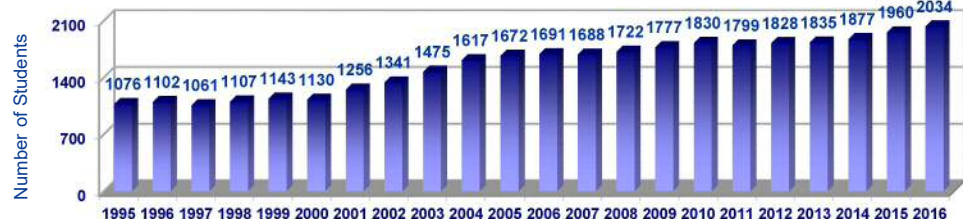
## B-CC Numbers

B-CC's enrollment reached 2,034 in June, 2016. The school remains ethnically and economically diverse: 56% Caucasian, 18% Hispanic, 15% Black, 5% Asian/Pacific Islander, and 6% multi-ethnic. Among all students, 9% were in ESOL (English for Speakers of Other Languages), and 12% qualified for the free- and reduced-price meals program.

In the 2015-16 school year:

- 95% of B-CC students were enrolled in honors/AP/IB/College-level courses.
- The IB program had 157 diploma students and 169 certificate students.
- Among the Class of 2016, 80% went to 4-year colleges and 18% to 2-year colleges.

## President’s Letter

Since 1995 when the Foundation was created, enrollment at B-CC has doubled. The school had approximately 1,000 students back then; today it has eclipsed 2,000.

Rising enrollment is in part a reflection of the confidence the community has in the school, as parents have grown more and more comfortable sending their students to B-CC. That’s surely a good thing.

But with that increase in enrollment comes a greater demand for the programs the Foundation supports. In the 2015-16 school year we were called upon to increase our investments in programs that serve high need students. And we were asked to provide more resources to support teacher professional development. We were pleased we could step up and deliver on those requests, and we offer our sincere thanks to all of our donors who helped make that possible.

This year we were very fortunate to welcome a new Principal to B-CC, Dr. Donna Jones. Dr. Jones brought a new energy and vision to B-CC, one that reflects high expectations for students and staff, and encourages collaboration among parents and community members to support student success.

We are pleased that we were able to continue to grow our partnership with B-CC this year and we look forward to making it even stronger moving forward.

## Our Business Partners

The Foundation is grateful for the support from our local businesses, which provided 7% of the funds the Foundation received in FY2016. In particular, multi-year pledges were made by two of the Foundation’s long-time supporters, the Chevy Chase Land Company and the EagleBank.

**The Chevy Chase Land Company**, in commemorating its 125th anniversary, established in May 2015 the “CCLC Smart Growth Scholarship” to be awarded to a B-CC HS senior planning to pursue a career in architecture, engineering, or land use/transportation planning. *“Our goal is to help inspire young people to work for solutions to the local and global sustainability challenges of the future,”* said Tom Regnell, the Land Company’s President and CEO.

The annual \$5,000 scholarship, administered through the B-CC HS Educational Foundation, is in addition to the \$40,000 already donated and pledged to the Foundation since 2010 to help fund the Foundation’s efforts to ensure that every B-CC HS student can succeed academically.

The 2016 recipient of the scholarship award is Nahom Tesfatsion who moved with his family from Eritrea five years ago. *“This scholarship will make it easier for me to pursue a degree, and one day I hope to return to Eritrea and work on environmental and infrastructure issues there,”* said the B-CC senior, who will be attending the University of Maryland at College Park.

**EagleBank**, the Foundation’s official bank, is a prominent regional bank with its headquarters in Bethesda. A Foundation supporter since 2009, it has made another pledge of \$10,000, payable over 3 years. Its generosity allows the Foundation to continue to promote high academic standards and success for all students at B-CC.

Significant donations also came from businesses matching contributions from their employees and in-kind donations from local businesses in support of the Foundation’s fundraising efforts.
